PLACE OF WORK

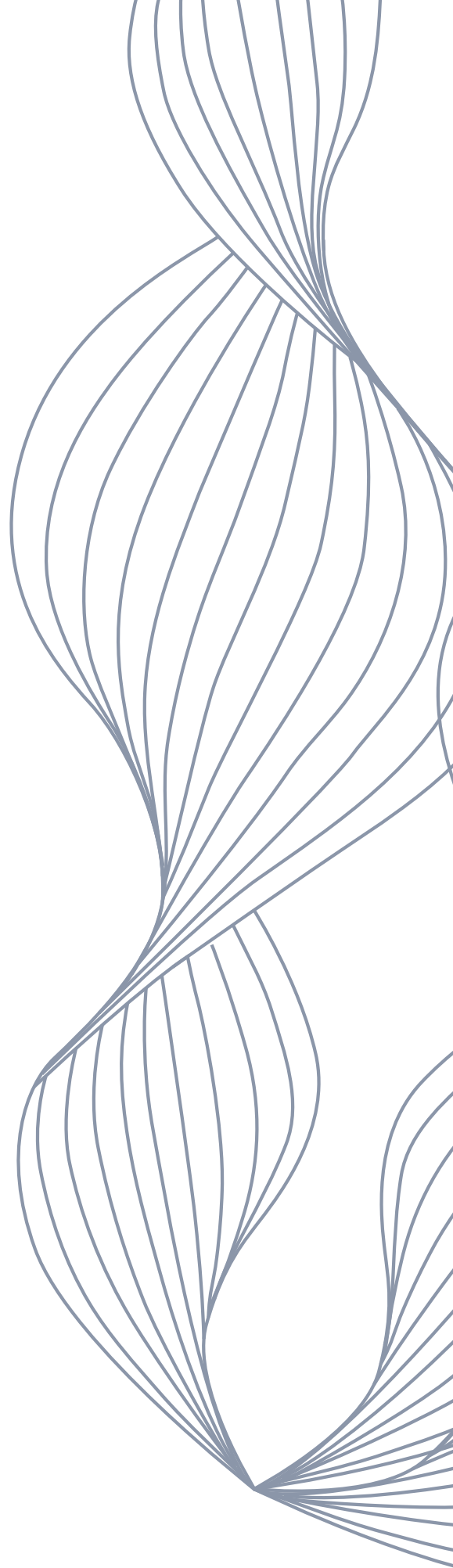
In your office or at home in the UK or abroad, our contractors can work wherever you need. This will be pre-agreed and set out in the assignment details.
