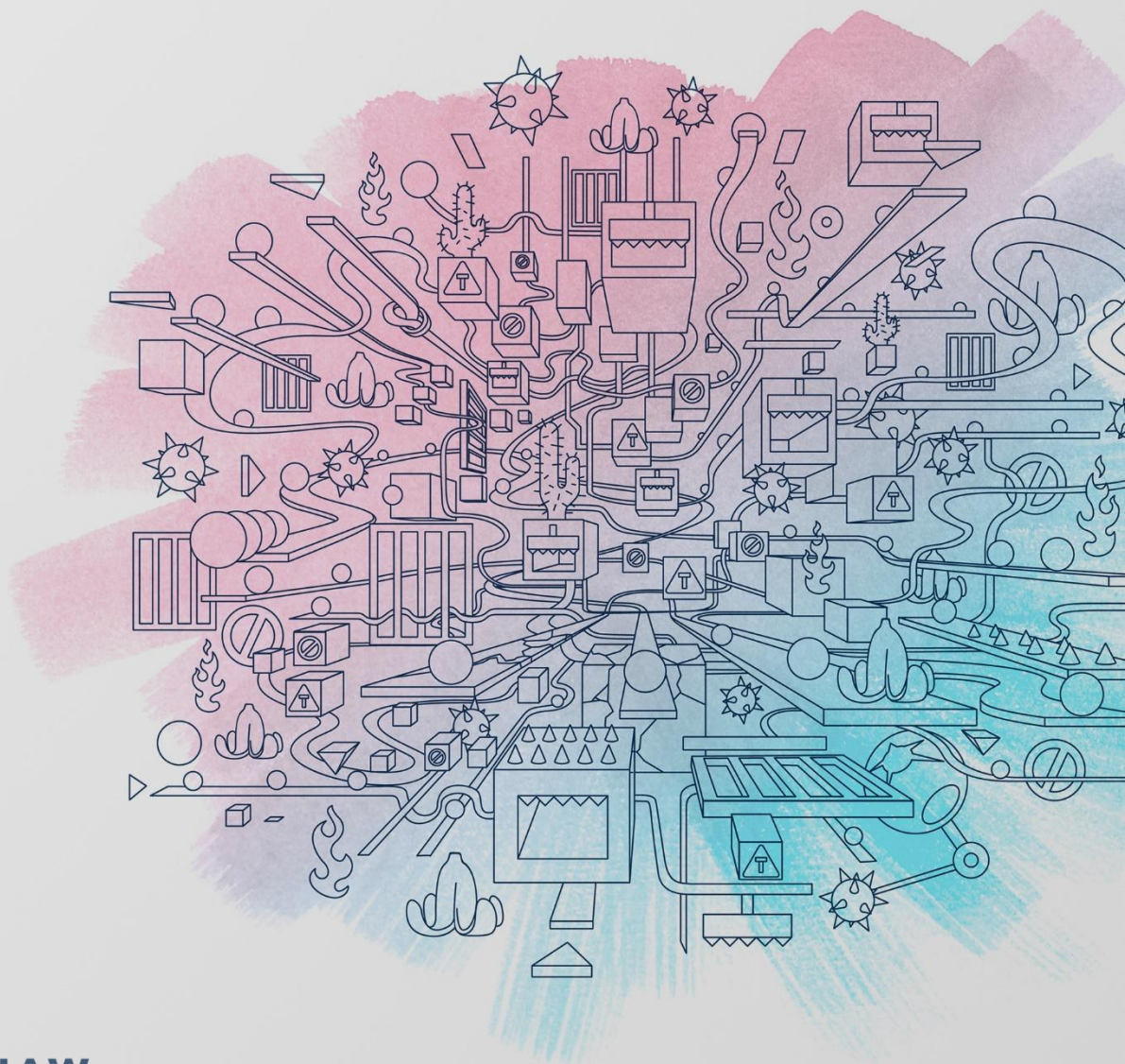


REGISTER OF LEGAL PRACTICE AREAS
